PENALTY

All bills are due and payable upon presentation, and if not paid within 15 days from date of bill a penalty of 5% will be applied on all bills. After 30 days an additional 5% penalty will be applied.

PUBLIC FIRE PROTECTION

Each fire hydrant \$ 57.96 per annum.

PRIVATE FIRE PROTECTION

When Private Protection is supplied, the annual charge for such service will be based upon the size of the service line required.

The following charges will apply:

Residential Sprinkler Connection	\$87.23 per annum
4" connection	\$ 468.88 per annum
6" connection	\$ 1,460.40 per annum
8" connection	\$ 2,926.08 per annum
10" connection	\$ 4,624.36 per annum
12" connection	\$ 7,301.60 per annum

A meter will be installed on all services. The cost of the entire installation, including the meter shall be at the expense of the applicant. The meter will remain the property of the Authority.

The entire installation shall be made in accordance with specifications and regulation of the Authority.
